Hypertension in Pregnancy - ILPQC

Antihypertensive therapy should be initiated for women with persistent chronic hypertension at systolic pressure of 160 mm Hg or higher and/or diastolic pressure of 110 mm Hg or higher. Consider treating patients at lower blood pressure (BP) thresholds depending on comorbidities or underlying impaired renal function.

SEVERE HYPERTENSION • Systolic blood pressure \geq 160 mm Hg or • Diastolic blood pressure \geq 110 mm Hg HYPERTENSIVE EMERGENCY • Persistent, severe hypertension that can occur antepartum, intrapartum, or postpartum • Defined as: - Two severe P values (\geq 160/110) taken 15-60 minutes apart - Severe values do not need to be consecutive

Maternal Safety Bundle for Severe Hypertension in Pregnancy

American College of Obstetricians and Gynecologists (ACOG) 2013, U.S. 1 Preeclampsia must include 1 of the following : SBP \geq 140 mm Hg or DBP \geq 90 mm Hg on 2 occasions $>$ 4 hours apart after 20 weeks' gestation in a previously normotensive woman

Preeclampsia Diagnostic Criteria Included in Major ...

Acute-onset, severe systolic (greater than or equal to 160 mm Hg) hypertension; severe diastolic (greater than or equal to 110 mm Hg) hypertension; or both can occur during the prenatal, intrapartum, or postpartum periods.
